THE EASTER SEASON

"What Sunday is to the Christian week – the day of resurrection, the day of the Lord, the inauguration of the New Creation – the Easter Season is to the liturgical year. The Easter season, then, is Sunday writ large and amplified to embrace a period of fifty days stretching from Easter Sunday to Pentecost. In the early centuries of Christianity, before there were separate feasts of Ascension and Pentecost, the

Fifty Days from Easter to Pentecost sought, 'like the Lord's Day [to] proclaim the lordship of Jesus as attested by his resurrection, ascension, and bestowal of the Spirit'.

"The Fifty Days, celebrated as one Great Sunday, underline the victorious, triumphant facet of the paschal mystery of Christ.
They bask in an aura of the risen Lord's abiding presence with his



Church, though it is still a hidden presence. They offer a foretaste of the heavenly kingdom where the faithful, clothed in white, will be gathered with the Lamb that was slain to give praise and glory to God."

HIGHLIGHTS

NEW VEHICLE POLICY FOR OMI LACOMBE

INTENT

To define procedures for the purchase and use of vehicles in OMI Lacombe Canada (OMILC).

DEFINITION

Vehicle: all motorized vehicles including, but not limited to cars, trucks, four wheelers, motorbikes, snowmobiles, boats, etc.

ASSUMPTIONS

- 1. The principle of religious simplicity will guide the members in the selection of vehicles. It should fit the simple lifestyle of a missionary. As well, in that spirit, consideration will be given to sharing vehicles within the community.
- 2. A vehicle is a significant investment of capital and should be respected as a community asset.
- 3. It is the responsibility of the Oblate to whom a vehicle is assigned, to maintain and service the vehicle according to the manufacturer's requirements and public safety standards; a designated individual will be given responsibility for the care of a community vehicle.

DIRECTIVE

The principle of religious simplicity will guide the members in the selection of vehicles. It should fit the simple lifestyle of a missionary. As well, in that spirit, consideration will be given to sharing vehicles within the community.

A vehicle is a significant investment of capital and should be respected as a community asset.

A designated individual will be given responsibility for the care of a community vehicle. It is the responsibility of the Oblate to whom a vehicle is assigned, to maintain and service the vehicle according to the manufacturer's requirements and public safety standards.

The District Community
Treasurer's Office will coordinate
the purchase of the vehicle with
the OMILC Finance Office. Final
approval by the Provincial Finance
office is required before any

vehicle purchase is finalized.

The OMI Lacombe Canada Provincial Council will set the maximum capital cost of vehicle purchases, excluding trade-in or taxes, on an annual basis. It is the practice of OMILC to purchase gently used vehicles. It is also the practice of OMILC not to purchase extended warranties on vehicles or components, anti-theft programs, such as window etching, or other extra cost dealer services. Exceptions to financial competency limits require the approval of the Provincial leadership on a case-bycase basis.

IMPLEMENTATION

Consideration for the purchase, sale or trade-in of vehicles will occur first at the BOC level (at budget time, if at all possible) and then with the District Community Leadership Team. The request for the purchase of a vehicle should be submitted in writing to the District Community Leadership Team, outlining the reasons for such a purchase, e.g., age of car, repairs needed, mileage, etc.

All vehicles (including recreational vehicles) must be registered for insurance purposes, and operated by a person with a valid driver's license. Insurance for the vehicle will be purchased and renewed by the District Community Treasurer's Office and OMI Lacombe Canada Finance Office and will meet the necessary statutory requirements to protect OMILC from any legal liability. In provincial jurisdictions where government coverage is mandatory (i.e., British Columbia, Saskatchewan and Manitoba), the basic minimum coverage will be

purchased through the appropriate authorities.
Additional insurance coverage, liability or otherwise, will be purchased by OMI Lacombe Canada Finance Office.

Annual vehicle and license plate registration will be done by the District Community Treasurer's/Administrator's Office.

When a member is transferred, consideration of whether or not the vehicle is transferred with the individual with be discussed and mutually agreed upon by the District Community Leadership Team/s involved. Together, the individual Oblate and District Community Treasurer's Office will be responsible for ensuring the vehicle registration is properly transferred if such a change is required.
