Global Treaty to Control Plastics Pollution: Sue Wilson's Takeaways



Sue Wilson, Executive Director of the Office for Systemic Justice (Federation of Sisters of St. Joseph of Canada) was one of the 2,500 delegates from 174 countries gathered at the fourth session of the United Nations Intergovernmental Negotiating Committee on Plastic Pollution, held in Ottawa in April 2024. The committee was set up to develop an international, legally-binding treaty targeting plastics pollution by the end of 2024. The overall goal is to eliminate plastic waste by 2040. A fifth, and final session, is scheduled for November this year in South Korea.

Sue outlines some of the concerns behind the negotiations: every year, over 430 million tons of plastic are produced, much of which ends up in our waterways, forests, and even our food. Developed countries, including Canada, often ship their plastic waste overseas, contributing to this global issue. Scientists have long raised alarm about the chemicals in plastics and the risk they pose to human health and the environment.

According to Sue, the major issue of debate during the Ottawa meeting was that "[while] civil society groups are calling for countries to adopt a legally-binding target to slash plastic production 78 percent by 2040...[the] fossil fuel lobbyists are working hard to ensure the final draft of the treaty won't contain a cut in plastic production...they were focused on recycling but without committing to putting the infrastructure in place for large-scale recycling." Sue reflects that such an approach "relies on the myth of recycling," ignoring data that shows that "only 9% of plastic gets recycled... [and that] most plastic is just not recyclable". For Sue, real solutions will involve significant cuts in plastic production.

Sue noticed tension in meetings over fair representation of international stakeholders. A key issue was that "some civil society delegates were pushing for more representation and participation by Indigenous Peoples, whose communities are among those most affected by plastic pollution." She observed that civil society groups also demanded a "human rights-based approach to negotiations," including a "just transition for impacted communities and plastic waste workers."

In Canada, Sue highlighted that while environmental groups advocate for production caps on plastic, the government is focusing on measures like phasing out harmful chemicals, restricting single-use plastics, increasing recycling, and creating a **Plastic Registry** — a monitoring and reporting measure for companies on plastic production, recycling and reuse.

As nations continue to negotiate an agreement in the final session, civil society groups will work for it to be as just and ambitious as possible.

Welcome, Sasquia Antúnez Pineda, ORCIE Researcher



Learning and Lobbying: Embracing the energy transition

In March 2024, ORCIE organized a three-day "Learning & Lobbying" series, which culminated in in-person meetings on Parliament Hill in Ottawa with MPs and top civil servants to discuss the transition away from fossil fuels, with a particular focus on **capping emissions**. Eight participants from various congregations attended the event, with most traveling from outside Ottawa.

The L& L process prepared two small teams to meet with MPs and top civil servants on Parliament Hill. Our preparation began with an **online panel discussion on Canada's transition away from fossil fuels** with guest speaker **Alex Cool-Fergus, National Policy Manager with CAN-Rac** and led by Genevieve Gallant, Executive Director of ORCIE and Sue Wilson, CSJ, PhD - Office for Systemic Justice, Federation of the Sisters of St. Joseph of Canada. This session addressed two key questions to consider in preparation for meetings with MPs and senior civil servants:

- 1. What are the legislative actions and moments to leverage right now in our transition to clean energy?
- 2. Where and how can we act to be a part of a 'new reset', understanding there is no room for new oil and gas production in Canada?

The second step involved an **in-person presentation** titled **"Brass tacks: Multilateralism from below,"** led by Genevieve Gallant, Executive Director of ORCIE at St. Paul University, Ottawa, followed by lunch. This session covered a review of the ORCIE's lobby guide, report-back documents, policy briefs, and elevator speech. We also trained participants for MP meetings and ended with small group discussions to set specific meeting goals.

The final step involved participants from the different congregations holding **in-person meetings on the Hill with MP's and top civil servants** ending with a concrete 'ask'. This final step concluded with a debrief and dinner to share experiences and feedback.



The Canadian Sustainable Jobs Acts, 2024



The Canadian Sustainable Jobs Act has been a move in the right direction, but there is still more ground to cover to bring about an equitable energy transition that is inclusive and leaves no one behind.

Bill C-50 (44-1) received Royal Assent in June 2024, becoming a law in Canada. The purpose of this act is to "facilitate and promote economic growth, the creation of sustainable jobs and support for workers and communities in Canada in the shift to a net-zero economy..."

This act requires the federal government to develop additional programs and policies to bring about an equitable economy for all that upholds Indigenous rights and ecological integrity, to align with the UN Declaration on the Rights of Indigenous Peoples and Canada's international climate commitments.

This act became a reality thanks to the push from labour, environmental organizations, community leaders, and Flood Parliament organizers, despite the opposition from the Conservative Party, who stalled its implementation when it was first called "The Just Transition Act".

But there is still more ground to cover:

A weakness of the Sustainable Jobs Act is its allowance for "transition" technologies like carbon capture and storage (CCS) as opportunities for sustainable jobs, despite uncertainties about their effectiveness in decarbonization and emission reductions. This provision enables the fossil fuel industry to continue operating as usual, impeding a fair transition to sustainability.

The Changes to Canada's Competition Act



Bill C-59: Assented in June 2024, includes an amendment focused on **truth-in-advertising**. This amendment will mandate that companies from all sectors provide evidence to **support their environmental claims**. While not specifically targeted at the oil and gas industry, the Bill will penalize oil and gas 'greenwashing' – false, misleading, or deceptive environmental claims made for the purpose of promoting a product or a business interest.

Not surprisingly, this Bill faces opposition from fossil fuels conglomerates because its provisions will have a significant impact on how companies market and promote their efforts to reduce their environmental footprint and address global climate change causes and effects. Climate advocacy and think tank groups have long been critical of environmental claims made by the oil and gas sector on the basis that investment in fossil fuel production is inconsistent with reaching global climate goals, as well as questioning the gap between energy industries pledges and their actions:



...The six Pathways member companies (CNRL, Cenovus, ConocoPhilips, Imperial, MEG, Suncor) deleted their corporate sustainability reports from their own websites, also apparently in response to provisions in the omnibus bill about a basic expectation that companies, of all shapes and forms, should be able to back up environmental claims with real evidence.

Invitation to Prayer: Jubilee Year





In the Jubilee Year 2000, Canada responded to Pope John Paul's call to cancel the debts of Global South countries, collecting a record number of petition signatures. The Canadian Ecumenical Jubilee Initiative successfully convinced the Chretien government to cancel bilateral debt from several highly indebted poor nations, contributing to over \$100 billion in debt relief for 35 of the world's poorest countries. Following this, the Make Poverty History campaign, supported by celebrities like Bob Geldof and Bono, further advocated for global poverty relief.

However, debt relief alone is not enough. Without structural reforms to the global financial system, such relief will remain a temporary fix. In 2025, we must push for governments to eliminate tax havens, levy currency transactions (Tobin Tax), and establish a UN-based multilateral debt mechanism, rather than relying solely on the IMF and World Bank.

Pope Francis now highlights a new injustice: the "ecological debt" between the global North and South. This debt reflects the fact that while there is a disproportionate consumption of resources by wealthier nations, catastrophic climate events tend to hit less developed nations harder, leaving those who contributed least to the climate crisis suffering the most.

ORCIE will join the international faith community journey to justice through the Jubilee Year 2025!
