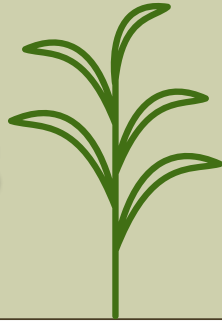

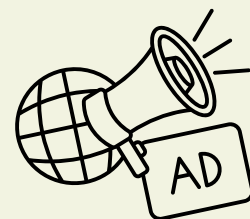

ORCIE Joins Rally for the Planet: No Faith in Fossil Fuels

On May 12, 2025, the Office of Religious Congregations for Integral Ecology (ORCIE) stood in solidarity with faith-based and environmental allies at the Rally for the Planet: No Faith in Fossil Fuels on Parliament Hill. This powerful, family-friendly event was the final stop of the two-day Pilgrimage for the Planet, a 200 km bike journey from Montreal to Ottawa calling on the Canadian government to endorse the Fossil Fuel Non-Proliferation Treaty—a bold step to stop the expansion of fossil fuel projects.

ORCIE's participation—represented by Executive Director Genevieve Gallant, Advocacy and Communications Officer Sasquia Antúnez Pineda, and Treasurer Joe Gunn—reflects our commitment to working in coalition to demand urgent climate action rooted in justice and the care for creation. With the federal election just behind us, this was a crucial moment to push the next government toward real climate leadership.

Led by the *Eastern Synod of the Evangelical Lutheran Church in Canada*, the Pilgrimage and Rally brought together a broad coalition of partners including *Fridays for Future Ottawa*, *CAFES Ottawa*, *OMI Lacombe (Le Centre Oblat)*, the *Mouvement Laudato Si' Movement Canada*, *KAIROS Canada*, and *ORCIE/BCRÉI*. ORCIE at the 2025 C7 Summit – Civil Society Unified Call for Debt and Climate Justice

In mid April, Cooperation Canada organized the Civil Society 7 (C7) Summit—a critical gathering of over 100 civil society representatives from across Canada—including Indigenous leaders, Global South activists, youth, and ecological justice advocates—who came together to shape the agenda flowing into the **G7 discussions in Kananaskis, Alberta.**

What Was Achieved at the Summit?

- The C7 Communiqué, built around four pillars—Climate & Environment, Economic Justice, Humanitarian Action, and Sustainable Development—**was officially handed to Canada’s G7 Sherpa, Cindy Termorshuizen**, in the presence of diplomatic representatives.
- Strong calls were made for a **just transition away from fossil fuels**, robust **climate finance**, **debt cancellation**, and **structural financial reform**, all grounded in human rights and global equity.
- Summit panels spotlighted threats from authoritarianism, shrinking civic space, extractive financial systems, Indigenous exclusion, and the need to center global voices.



ORCIE’s Key Participation:

- **Genevieve Gallant** and **Sasquia Antúñez Pineda** from ORCIE joined delegates from KAIROS and Development & Peace, among other civil society groups.
- ORCIE’s participation was focused on climate, energy and the environment—especially linking climate finance with debt cancellation and reframing foreign aid as a form of global reparations.

ORCIE’s involvement in the C7 Summit reinforced our commitment to an integral approach—one that not only links ecological and financial decolonization, but also recognizes the importance of working alongside other civil society organizations to strengthen our collective impact in the broader G7 dialogue. This perspective is central to our role in the Jubilee campaign *Turn Debt into Hope*.

Next Steps & ORCIE’s Role

- ORCIE patrolled developments at the G7 Leaders’ Summit (June 16–17, Kananaskis) and associated People’s Forum activities in Calgary in June.
- Our advocacy will focus on strategic collaboration with partners on how to bring the Jubilee petition to world decision-makers, holding them accountable to the commitments outlined in the C7 Communiqué.

G7 Jubilee People’s Forum: Connecting the Dots on Debt Cancellation and Climate Justice

From July 12–15, ORCIE was proud to join voices from across the globe at the G7 Jubilee People’s Forum in Calgary, where Chair of the Board Sue Wilson and Executive Director Genevieve Gallant represented our shared commitment to integral ecology and economic justice.

Held in the days leading up to the **G7 Summit in Alberta**, the **Jubilee Peoples’ Forum** in Calgary brought together people from across Canada to explore how global financial debt, ecological debt, and systemic inequality are deeply interconnected—and why, as Sue Wilson reflects, these challenges must be addressed concurrently. ORCIE joined KAIROS, Development and Peace – Caritas Canada, Citizens for Public Justice, and the Canadian Council of Churches at the Forum to deepen our collective understanding and commitment to these shared concerns.

ORCIE at the G7 Jubilee People's Forum: Connecting the Dots on Debt Cancellation and Climate Justice

“Who Owes Whom?”: Understanding the Debt Trap

As Development and Peace vice-president Tashia Toupin aptly put it, the issue of debt can feel overwhelming—politically, economically, culturally, and ideologically. Yet the Forum helped to demystify these dynamics, showing how unjust debt, particularly in the Global South, is both a result of and contributor to structural inequality. ORCIE Chair Sue Wilson helped unpack these complex relationships through a lens of integral ecology.

“*At the rally, a bystander came up to me and said, ‘Your group is concerned about a lot of issues.’ I looked at the signs the people around me were holding: Turn Debt into Hope. Climate Justice. Reform the Financial System. People before Profit. Who owes whom? Where he saw different issues, I saw the multifaceted and interconnected aspects of the Jubilee Debt Campaign.*” — Sue Wilson, CSJ

Sue emphasized how unsustainable debt in the Global South is often driven by:

- Global economic shocks such as the COVID-19 pandemic and war in Ukraine;
- Predatory lending practices by private financial institutions;
- International systems that force countries to prioritize debt repayments over development;
- Lack of global rules on responsible borrowing and lending.

Debt cancellation, then, is not charity. It’s a form of justice—especially when viewed through the lens of **ecological debt**, the concept that the Global North countries, including Canada, owes a climate and resource debt to the South and Indigenous communities due to centuries of exploitation and emissions.

“*This is not charity, but a commitment made in the 2015 Paris Agreement which states that countries must fund global climate actions according to their responsibility for the climate crisis and their ability to pay. Countries like Canada (wealthy, large historic climate polluter, and a key producer of crude oil and gas) must contribute our fair share towards addressing the impacts of climate change in the Global South (Canada’s Fair Share Platform).*”

What are we calling for?



“

The Global North can make payments on this climate debt by funding climate adaptation and mitigation in the Global South and by contributing to the Loss and Damages fund. The cancellation of unsustainable debts is another way of freeing up money so countries badly impacted by climate change can invest in climate adaptations and mitigation. If the Global North cancelled debt payments to low and lower-middle income countries, it could free up approximately \$109 billion for climate action globally (Canada's Fair Share Platform).”

Participants at the Jubilee People's Forum went beyond critique to present clear, actionable solutions—many of which will shape ORCIE's upcoming advocacy with the federal government. These proposals include:

- Cancelling unjust and unsustainable debt without conditions;
- Supporting the creation of a UN Global Debt Framework for transparent and fair resolution;
- Tripling Canada's climate finance pledge to \$15.9 billion/year, with a focus on grants over loans;
- Enacting windfall taxes on oil and gas companies instead of continuing public subsidies;
- Reforming trade rules to protect human rights, land, and ecosystems over corporate profit.

Who can we act with?

Additionally, during the Forum, a key highlight was deepened collaboration with the Calgary Interfaith Council, a 30-year-strong alliance of diverse religious communities. This relationship opens new pathways for ORCIE to expand its interfaith advocacy work on economic and climate justice.

Genevieve Gallant, shares this reflection on two key moments from the Forum that offered grounded, forward-looking direction for the campaign—rooted in both inter-faith collaboration and Indigenous leadership.

Forging the Path Ahead: Insights from the People's Forum and ORCIE's Fall Advocacy

How can we expand our reach with the Jubilee Turn Debt Into Hope campaign?



At the G7 Jubilee People's Forum in Calgary this past June, ORCIE joined over 100 participants, social justice activists and people of faith from across Canada to call for global debt justice. How were we able to build up the Jubilee Turn Debt Into Hope movement and what did we learn about advancing debt justice in 2025?

Beyond workshops, planning sessions and fruitful discussions, the program included two key elements that demonstrated innovative yet practical ways forward for the campaign.

The G7 Jubilee People's Forum began with a dynamic Interfaith Service where multiple faith traditions prayed for justice in the Jubilee year. Led by the Calgary Interfaith Council, the service included voices and elements from Muslim, Hindu, Indigenous, Jewish, Buddhist, Bahai, Sikh, Unitarian and Christian traditions, followed by a meal from the community kitchen of the Calgary Sikh gurdwara.

The Calgary Interfaith Council, 30 years strong, not only focuses on deepening relationships across faith traditions, but they also urge members of their community to educate themselves, become advocates for peace and justice, and pave the way for integrated coexistence for future generations.

Members of the Council did not just participate in the first evening but stayed throughout the Forum and deepened their engagement with the Jubilee campaign. **It was a vivid example to the ecumenical movement of the need to expand our relationships and work beyond our own faith and cultural communities.** In Christian communities we often invite one or two other faith traditions to join the existing group, expecting newcomers to adapt to the group's own history and way of doing things. Instead, what if we reach out to local interfaith groups, to create and build relationships that could lead to collaboration? Or what are the local Christian cultural communities, not necessarily part of the mainline churches, who we have neglected to include in our ecumenical work?

The city of Calgary is on the traditional territories of the Peoples of Treaty 7, which include the Blackfoot Confederacy (comprised of the Siksika, the Piikani, and the Kainai First Nations), the Tsuut'ina First Nation, and the Stoney Nakoda (including Chiniki, Bearspaw, and Goodstoney First Nations). Calgary is also home to the Métis Nation of Alberta.

With a desire to go beyond land acknowledgements, each day of the Forum included dedicated time for an opening session by an Elder from the three main nations. A high point of the weekend was travelling to Mînî Thnî for an interfaith prayer meeting on sacred ground at the **Stoney Nakoda First Nations Medicine Wheel**. Leaving the classrooms to see the stunning mountains, the prairie flowers and the Bow River allowed for deeper integration of mind, heart and spirit. Reverend Tony Snow and Elders from the Bearspaw, Chiniki and Goodstoney First Nations joined the interfaith circle at Mînî Thnî to lift up prayers for the Jubilee vision for the world. Rev. Tony: "Built by Elders from the Ecumenical circle, the Medicine Wheel commemorates the journey of restoration that our people have traveled to honour the wisdom of our ancestors. In this space we invite interfaith prayer and ceremony to lead us. In this sacred space we bring hopes and dreams, guided by the wisdom of many traditions."

Alongside education and strategizing at the Forum, creating space for Indigenous Elders to share their wisdom and for each person to set foot on sacred Indigenous land provided us a chance to catch our breath, to taste a decolonized Christianity, and be stunned by the glory of creation. This time of integration set a strong foundation for the action steps where participants spoke about debt justice in local churches and rallied in the streets of Calgary.

Hope in Action: A Global Movement

The Forum offered more than analysis—it fostered relationships, re-energized commitments, and created space for a shared vision. As our partners at Development and Peace beautifully reflected in their post-event summary, "Hope was created, nurtured, and shared" through this collective gathering. Their thoughtful reflection captures the spirit of the Jubilee People's Forum and the momentum it generated.

ORCIE Sponsors Global Dialogue on Debt Justice



On July 14, ORCIE was proud to co-sponsor the global webinar *Beyond Default: The Liberating Power of Debt Reform*, an official side event of the 2025 High-Level Political Forum (HLPF). **Hosted by the Congregations of St. Joseph NGO to the United Nations**, this timely conversation brought together global voices to explore pathways toward long-term debt sustainability, justice, and ecological accountability.

The event focused on Sustainable Development Goal (SDG) target 17.4, addressing the urgent need to confront unjust global debt burdens that hinder the flourishing of communities across the Global South. Participants engaged with key themes including health equity (SDG 3), gender equality (SDG 5), and decent work (SDG 8), all through the lens of debt reform and ecological justice.

We heard from inspiring speakers who are working at the intersection of economics, justice, and faith, and who are mobilizing around the Global Jubilee Year Campaign—a call to transform unjust debt structures and reimagine global solidarity:

Jubilee People's Forum: A Voice Amid Global Headlines



Media coverage of the G7 events in Alberta were largely dominated by pressing geopolitical developments, including Trump's arrival (and departure) and the ongoing genocide in Gaza. Yet ORCIE's message at the People's Forum was present and reflected a growing call to recognize ecological debt and lift the burden on low-income countries. **As Genevieve Gallant, shared in The Catholic Register:**

“*The Jubilee 2025: Turn Debt into Hope campaign is calling on Canada to be at the forefront of a solution to tackle ecological debt. Canada has an opportunity to continue being a leader in international development assistance. This is a way they can make a huge difference: to reduce the debt and set up a UN framework for negotiating a debt. That is not an expensive thing. It is just making a way for the debtors and creditors to come together and figure out what to do when there are crises.*”

ORCIE response to Catholic Register opinion piece, “Naïve nuns play squarely into Hamas' hands”

The Office of Religious Congregations for Integral Ecology (ORCIE) has issued a response to the opinion piece published in The Catholic Register on July 12, titled “[Naïve nuns play squarely into Hamas' hands.](#)” The article misrepresents the intent and integrity of a letter signed by many ORCIE members, addressed to Prime Minister Mark Carney, which called for humanitarian aid to Gaza and an end to ongoing violence:

“*We support your insistence that military operations in Gaza must stop, and humanitarian aid must increase greatly. Likewise, we call on Hamas to release immediately the remaining hostages...The continued existence of this humanitarian crisis diminishes the humanity of us all.*”

Our response letter expresses deep disappointment over the decision to publish such a dismissive and divisive opinion, and reaffirms the faithful and justice-rooted witness of religious congregations calling for peace.

“*It is in this spirit that we offer our complete support for the letter sent by religious congregations to Prime Minister Carney. The opinion piece that you have chosen to publish is deeply insulting to the religious congregations and to all of those globally who are calling for a ceasefire and for an end to the humanitarian crisis in Gaza, including Pope Leo XIV, UN Secretary General António Guterres, and many others.*” ~ Darlene O'Leary

TAKE ACTION

Spring Advocacy

As part of our work on the Jubilee 2025 Turn Debt Into Hope campaign, **ORCIE-BCRÉI sent a letter to the Honourable Dominic Leblanc in February**, during his short time as **Finance Minister**, as well as a **letter to PM Mark Carney** when he became the newly elected leader of the Liberals in March. These moments may seem like flashes in a pan (was this only a few months ago?) but they are part of setting the stage for in person meetings and keeps the urgent issue of debt cancellation and climate justice front and centre.

On the issue of climate finance and ecological debt, staff from ORCIE-BCRÉI and other Jubilee 2025 organizations met with Associate Assistant Deputy Minister Steven Kuhn from Finance Canada and a few other Directors as they were preparing for the 4th International Conference on Finance for Development <https://financing.desa.un.org/ffd4>. They were very encouraged by the conversation about both financial debt and ecological debt as Canada prepares for G7, G20 and COP30.

Laudato Si 10th Anniversary

The Path to COP 30: Climate Leadership from Churches of the Global South



It has often been remarked that, in the days before the 2013 Conclave that elected him as pope, Jorge Bergoglio told the Cardinals that, “The church is called to come out of herself and to go to the peripheries, not only geographically, but also the existential peripheries...”

Over a decade later, these “peripheries” turned the tables – they arrived at the metropole to deliver their own historic challenge to all Christians, especially those of us in the Global North. Could anyone have predicted what topic would be their churches’ utmost priority?

Global warming has been defined as “an existential issue of justice, dignity and care for our common home.”

In a press conference at the Vatican on July 1, 2025, three Cardinals, presidents of their regional organizations, presented a message from the Catholic Episcopal Conferences and Councils of Africa, Asia, Latin America and the Caribbean on the occasion of COP30 (the UN conference on climate change, scheduled for Brazil in November 2025.) Their 30-page text is titled, “A Call for Climate Justice and the Common Home: Ecological Conversion, Transformation and Resistance to False Solutions.”

This year marks the 10th anniversary of the publication of Francis’ encyclical, *Laudato Si*, as well as the legally binding treaty at COP21 in Paris that famously committed 196 nation signatories to limit global warming to an increase under 1.5 degrees Celsius. Nonetheless, the bishops call for a profound ecological conversion because global warming already reached a 1.55 degrees C increase in 2024.

Be Not Afraid (Matthew 28:5): Religious Congregations Embracing the Call to Conversions, by Joe Gunn



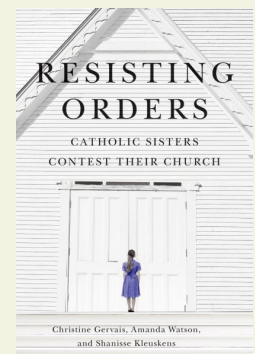
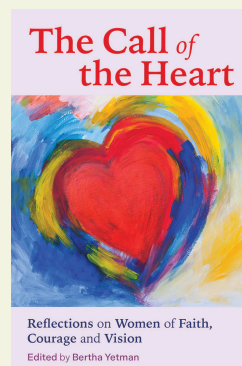
Who are the people who envisioned the need, and since 2021, do the work, to fulfill the mission set out as: “skillfully engaging with policymakers creating maximum impact for change.”

Among the over two dozen Catholic religious congregations that have donated to the initiative, only two “institutes of consecrated life” are comprised of males. By far, the majority of ORCIE members, supporters and activists are female members of religious congregations.

In the early summer of 2025, two new books were published that reveal detailed accounts of the contributions of female religious in Canada, as well as their on-going struggles to remain true to their various charisms.
